NOTICE OF INTENT TO TRANSFER TO 94-C

Dear Secretary Phillips:

We represent the Applicant, Morris Ridge Energy Center, LLC, a subsidiary of EDF Renewables, Inc. in the above-referenced proceeding. Morris Ridge Energy Center LLC ("MREC" or "Applicant") is proposing to construct and operate a solar electric generating facility in the Town of Mt. Morris, Livingston County, New York (the "Facility"). On July 1, 2020, MREC submitted an application seeking a certificate of environmental compatibility and public need (the "Application") from the New York State Board on Electric Generation Siting and the Environment (the "Siting Board") pursuant to Article 10 of the Public Service Law (PSL) and the Siting Board's rules (16 NYCRR Part 1000 et seq.). On November 13, 2020, the Siting Board determined that the Application together with the Applicant's supplemental filing made on September 8, 2020, October 14, 2020, October 21, 2020 and November 10, 2020 complied with Public Service Law Section 164.

Pursuant to Section 94-c of the New York State Executive Law and 19 NYCRR § 900-3.2,¹ MREC hereby provides notice that it is electing to be subject to Executive Law Section 94-c and will be transferring the Application to the Office of Renewable Energy Siting ("ORES" or the "Office").

¹ These regulations have not yet been adopted.

As required under Section 94-c the Applicant will provide the following to ORES on or about December 18, 2020 (collectively, the “Transfer Application”):

- i. A copy of this notice to the Secretary of the PSC advising of the Applicant’s election to be subject to Executive Law Section 94-c;
- ii. A completed transfer of application form;
- iii. A copy of the Application materials submitted pursuant to the PSL Article 10; and an explanation as to how the PSL Article 10 application materials demonstrate compliance with the proposed uniform standards and conditions set forth at 19 NYCRR 900-6;
- iv. Copies of documentation identifying those matters and issues that have been identified and resolved in the PSL Article 10 proceeding, if any;
- v. Any additional information that may be required in order to enable the Office to make the findings and determinations required by law; and
- vi. The fee to be deposited in the local agency account in an amount equal to one thousand dollars for each one thousand (1,000) kilowatts of capacity, which may be adjusted from time to time by the Office to account for inflation.

Upon the filing of such information with ORES, the Transfer Application shall be complete in accordance with Section 94-c on the basis that the Application was deemed complete under Article 10. However, the Applicant anticipates providing supplemental materials in order to assist ORES’ review under the Section 94-c process.

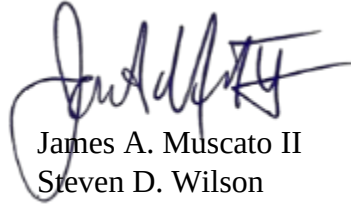
Within thirty (30) days of the date of the filing of the Transfer Application any local agency or potential community intervenor² seeking funding from the local agency account must submit a request for initial funding to the Office of Renewable Energy Siting, at 99 Washington Avenue, Albany, New York 12231, Attention: Request for Local Agency Account Funding.

Pursuant to Section 94-c and the draft regulations, no later than sixty (60) days following the filing of the Transfer Application ORES is required to issue a combined notice of availability of draft permit conditions and will provide additional details regarding the public comment period and public comment hearing, and issues determination process. ORES has one year from the date the Transfer Application is filed to issue the final permit.

² *Potential community intervenor* means any person residing within the Town of Mt. Morris Livingston County, New York or residing within one (1) mile of the proposed facility or any non-profit organization that can demonstrate a concrete and localized interest that may be affected by a proposed facility and that such interest has a significant nexus to their mission.

Parties to the Article 10 proceeding are encouraged to contact the Applicant or ORES if they have additional questions regarding the Section 94-c process.

NOTICE OF SUBMISSION OF 94-c TRANSFER APPLICATION

Morris Ridge Solar Energy Center, LLC (“Applicant”) will be transferring its Application to construct the Morris Ridge Solar Project, a major solar electric generating facility, from Article 10 of the New York Public Service Law to the Office of Renewable Energy Siting (the Office) pursuant to Section 94-c of the New York State Executive Law (“94-c Process”). This notice announces that on or about December 18, 2020, the Applicant will file a Transfer Application pursuant to 19 NYCRR 900-3.2 seeking a Permit from the Office authorizing the construction and operation of the Facility. Upon the filing of the Transfer Application, the Transfer Application shall be complete in accordance with Section 94-c on the basis that the Application was deemed complete under Article 10.

The new 94-c Process replaces the Article 10 process for the permitting and siting of renewable energy facilities with a generating capacity of 25 megawatts or more. Section 94-c will be implemented by the newly established Office of Renewable Energy Siting and establishes a review process with uniform standards and conditions for all projects.

The Facility is a proposed solar-powered electric generation project consisting of up to 177 megawatts (MW) of solar electrical generation and up to 83 MW of energy storage generation (total generation will be limited to 177 MW) to be located in the Town of Mount Morris, County of Livingston, New York. The Facility will include approximately 600,000 photovoltaic (PV) solar panels and their rack/support systems; direct current (DC) and communications cables connecting the panels to multiple decentralized inverters located adjacent to the PV solar panels; the inverters, with their support platforms, control electronics, and step-up transformers; buried alternating current (AC) medium voltage collector circuits; fencing and gates around each array of panels; access roads; temporary laydown/construction support areas; a medium voltage-to-transmission voltage collection substation, with associated equipment and fenced areas; a point of interconnection (POI) switchyard with associated equipment and fenced area (to be owned by New York State Electric and Gas Corporation [NYSEG]); and a potential 83 MW energy storage facility.

The Facility is a zero-emission solar energy facility that will assist the State in meeting the goals of the Climate Leadership and Protection Act and State Energy Plan, which includes obtaining 70% of energy generation from renewable sources by 2030 and significantly reducing greenhouse gas emissions. Other positive impacts of the Facility include diversification of energy supplies, new employment opportunities (both temporary construction employment and full-time jobs), and increased revenues to the Town of Mount Morris, Livingston County, Mount Morris Central School District and Keshequa Central School District, payments to the local hospitality industry, and purchase of local supplies and goods. In addition, the Applicant has attempted to minimize impacts to land associated with the Facility by limiting the disturbance to forested lands and wetlands to the maximum extent practicable. The Applicant submitted an Application that includes extensive studies evaluating the potential impacts associated with the Facility and identified methods which have been agreed to be implemented to avoid, minimize and mitigate potential impacts.

This notice is being provided in accordance with 19 NYCRR 900-1.6(c) and will be published at least three days prior to the filing of the Transfer Application. In addition, a copy of the Transfer Application will be served on the Chief Executive Officer of each municipality in which any portion of the Facility is located, as well as those persons and agencies enumerated in 19 NYCRR 900-1.6(a).

Upon filing the Transfer Application, the Applicant will provide funding to be disbursed by the Office to local agencies and potential community intervenors to help pay expenses, including attorneys and consultants, associated with participating in the 94-c process. Within thirty (30) days of the date of the filing of the Transfer Application any local agency or potential community intervenor seeking funding from the local agency account must submit a request for initial funding to the Office of Renewable Energy Siting at 99 Washington Avenue, Albany, New York 12231, Attention: Request for Local Agency Account Funding.

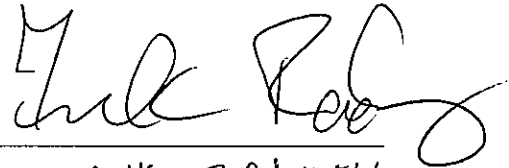

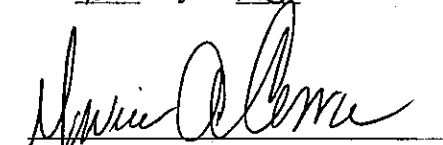
