Project Description and Proposed Change:

Pursuant to the Act and Regulation, the Project in respect of which the Renewable Energy Approval was issued, is a 12-megawatt (MW) Class 3 Solar Facility used to convert solar energy to electricity.

An application has been made to the Ministry of the Environment, Conservation and Parks (MECP) to change the project and alter the terms and conditions of the existing Renewable Energy Approval. The change is to the conditions of the existing Renewable Energy Approval as a result of the main power transformer at the substation not being constructed for the Project. There is no change to the total maximum name plate capacity of 12 MW to the facility and the overall project location remains unchanged. The project location is shown on the map.
