Dear Neighbour,

The purpose of this letter is to inform you of a schedule change related to the Vulcan Solar project (the 'Project'). Initial development work targeted an in-service date of December 2018, however, despite our best efforts, we have been unable to secure the necessary commercial certainty to move forward.

As such, we are extending the planned in-service date to **December 31, 2023**. This extension request, being filed for approval with the Alberta Utilities Commission ('AUC'), will provide the Project team additional opportunity to secure the necessary commercial contracts required to invest in this incredible project. Field studies were conducted by the Project team and reviewed by Alberta Environment and Parks ('AEP') prior to AUC submission in 2016. Since that time the Project has continued to keep these studies current; no AEP related concerns have been raised. **No changes to the layout, size or technology are proposed at this time.**

EDF Renewables Canada Inc ('EDFR') has been investing in Alberta since 2013 with the development and construction of the Blackspring Ridge Wind Project. Most recently, EDFR was awarded a 20-year agreement with the Alberta Electricity System Operator ('AESO') for its Cypress Wind Project, a 202MW wind facility near Medicine Hat. We remain dedicated to the Project and believe renewables will play a vital role in diverse energy mix for Albertans.

We appreciate your understanding and continuous support. **A follow up call will be made to you, to confirm the receipt of this letter.**

We have included two (2) documents with this letter:

- A Project map showing the Project boundary and proposed layout (this is unchanged from the original layout presented in 2016); and
- The Alberta Utilities Commission (AUC) Brochure — *Public involvement in a proposed utility development*.

We look forward to receiving your feedback about this proposed schedule change. We will be filing our application with the AUC towards the end of June 2019.
